## - Tree Removal – corner of Beech and Hall Streets

Mayor Nickerson expressed concern about the overgrown state of the large spruce tree that is located at the corner of Beech and Hall Streets and is currently used as the annual Christmas tree. Not only is the tree in jeopardy of blowing down but it has become increasingly difficult and dangerous for the Public Works Department to string lights on each December. The tree is too tall to be manageable for them.

Mayor Nickerson is suggesting that the tree be brought down and a new more manageable tree be planted to replace it in the same vicinity. The roots of the existing tree, emotional attachment to the tree and placement of the new tree were all discussed.

The Town Clerk/Treasurer has spoken to the Public Works Department to see if they would be able to bring the tree down and they have agreed that they can manage the task. The following motion was made;

It was duly moved and seconded that the spruce tree at the corner of Beech and Hall Streets be removed with the intention of replacing it with a new tree in the same vicinity early in the new year. In the interim the Town will buy a cultivated tree annually until the newly planted tree matures.
